### **Assumption of Risk**

Participation in physical activities can involve motion, rotation, and height in a unique environment and as such carries with it a certain assumption of risk. The undersigned, on behalf of him/herself, and any minors for which they are the parent or guardian, (hereafter collectively "participants") acknowledges that the physical activities involved in gymnastics, tumbling and cheerleading involve motion, rotation and heights for the participants in a unique environment and as such carries with an inherent risk of injury or even death. Participants acknowledge this risk and choose to voluntarily enter upon the premises of Competitive *Edge* Athletics, Inc., and undertake such physical activities and voluntarily assume any and all risks of loss, damage or injury that may be sustained by the participants or any property owned by them while on or upon said premises. In signing this Release, the undersigned acknowledges:

- a) That he/she has thoroughly read and understands completely, the terms of Registration, Release of Liability/Indemnity form and signs it voluntarily,
- b) That the undersigned signing either for themselves, or as Legal Guardian is, in fact, the true and legal guardian and has the consent of the participant.

### **Release of Liability and Indemnification**

The undersigned, on behalf of him/herself, and any minors for which they are the parent or guardian, (hereafter collectively "participants") being fully aware that severe injuries, including permanent paralysis or death, as well as other associated injuries and losses can occur in sports and activities involving height or motion, those activities including, but not limited to: tumbling, trampoline, gymnastics, dance and cheerleading, which shall occur at the premises of Competitive *Edge* Athletics, Inc., does hereby consent to participants' participation in all such activities occurring at said premises. Further, the undersigned, in consideration of said participation on behalf of the participants, their heirs, administrators and executors, does hereby release and forever discharge Competitive *Edge* Athletics, Inc., the owners, operators, directors, officers, agents and employees of Competitive *Edge* Athletics, Inc. from any liability, claim, demand, action or right of action, of whatsoever kind or nature, either in law or in equity, arising from or by reason of any bodily injury or personal injuries known or unknown, death and/or property damage resulting or to result from any accident, or mishap, whether by negligence or not, of any kind or nature which may be suffered by participants while on the premises of Competitive *Edge* Athletics, Inc., whether participating in any programs or activities of Competitive *Edge* Athletics,

Inc., or not. Further, the undersigned, in consideration of said participation on behalf of the participants, their heirs, administrators and executors, does hereby release and forever discharge Competitive *Edge Athletics, Inc.*, the owners, operators, directors, officers, agents and employees of Competitive *Edge Athletics, Inc.*, from any claim whatsoever on account of first aid, treatment or service rendered to participants during participation in any programs or activities of Competitive *Edge Athletics, Inc.* Further, it is affirmed that sufficient insurance covering all such injuries and damages is in full force and effect covering participants throughout all such programs and activities.

Further, the undersigned on behalf of the participants, their heirs, administrators and executors, does hereby to indemnify and hold harmless Competitive *Edge Athletics, Inc.*, the owners, operators, directors, officers, agents and employees of Competitive *Edge Athletics, Inc.*, from any loss, liability, damage or cost they may incur due to the presence of participants in or upon the premises of Competitive *Edge Athletics, Inc.*, whether caused by negligence of Competitive *Edge Athletics, Inc.*, the owners, operators, directors, officers, agents and employees of Competitive *Edge Athletics, Inc.*, or otherwise.

### **Medical Emergencies**

In any event of an accident or emergency, the undersigned hereby authorize my child to be transported to a hospital for medical treatment and the undersigned hold Competitive *EDGE Athletics, Inc.* and its representatives harmless in the execution of such. Additionally, I hereby agree to individually provide for all medical expenses which may be incurred by me or my child(ren) as a result of any injury sustained while participating at or for Competitive *Edge Athletics, Inc.* the undersigned, the minor's parent(s) or legal guardian(s), understand the nature of the activities my child(ren) will be involved in at Competitive *Edge Athletics, Inc.* and the minor's experience and capabilities, and believe the minor to be qualified, in good health, and in proper physical condition to participate in such activities. The undersigned hereby release, discharge, covenant not to sue and agree to indemnify and save and hold harmless each of the releasees from all liability claims, demands, losses, or damages on the minor's account caused or alleged to be caused, in whole or in part by the negligence of the "releasees" or otherwise, including negligent rescue operations. I further agree that if, despite this release, the undersigned, the minor, or anyone on the minor's behalf make(s) a claim against any of the releasees named above, the undersigned will indemnify, save, and hold harmless each of the releasees from any litigation expense, attorney fees, loss liability, damage, or any cost that may occur as the result of such claim.

**Classes**

\*If at any time fewer than three students are REGISTERED for a tumbling class that class will be shortened by 15 minutes.

\*A minimum of 3 registered students may be required for each Class.

\*Please plan on attending all scheduled classes.

\* Please note the tuition fees listed are per month. All of our classes are priced per month, regardless of the number of classes in the month. Allowances for holidays, gym closures, weather related closures, extra class days, etc. are all taken into consideration over the course of the year to establish the pricing of our classes per month.

**Make up classes**

Make ups for missed classes will be made up by open gyms ONLY. You must see or call the front desk to make them aware that your athlete will not be at class and will need to schedule a make-up for open gym. The makeup open gym must be done within thirty days of the class missed.

\*Your athlete will only be permitted 4 make up classes within a calendar year.

**Class Payment Policy & Drop Policy**

There is a \$50.00 annual registration fee per student or \$75.00 per family due before the first class. Class tuition is due on the first of the month. Payments for all fees can be made in person at the Competitive *Edge* Athletics, Inc. Credit card information is required for registration but your card will not be charged at this time. If tuition is not paid by the Seventh of the month, your credit card will be charged on the eighth, plus an additional \$15.00 late fee. Declined credit card charges or returned checks will result in a \$30.00 fee. If delinquent accounts are not reconciled by the eighth, the student will be dropped from the class. A re-enrollment fee of \$20.00 will apply. We honor Visa, MasterCard and American Express.

\* If you wish to drop a class , it is your responsibility to do so. All withdrawals must be in writing with a notice to drop class form or through the customer portal by the 1<sup>st</sup> of the month or you will be financially responsible for the class tuition until you do so. Phone calls, verbal or voice messages, or absence from classes are not accepted as a method for dropping a class.

\*There will not be any proration for classes dropped after the 1<sup>st</sup> of the month.

**Credit or Bank Draft Authorization Agreement**
